二〇一八／二〇二〇年度中學學位分配
有關小六下學期校內成績評核及中一自行分配學位行政程序的修訂安排

因應新型冠狀病毒感染疫情的發展，教育局於二〇二〇年一月三十一日宣布全港學校不會在三月一日前復課。受延遲復課的影響，本年度中學學位分配辦法(中一派位)的行政程序將作出相應調整，讓學校有足夠時間處理相關工作。

小六下學期校內成績評核安排

2. 為讓學校有較充裕的時間安排小六下學期校內成績評核及相關工作，本學年呈交有關評核積分的限期會由原訂的四月二十四日(星期五)順延至五月十一日(星期一)。由於復課的日子仍要視乎疫情發展而定，若學校未能在三月九日(星期一)或以前復課，學校毋須進行是次評核及呈報積分。學生的派位組別將根據他們經調整後的小五下學期及小六上學期校內成績決定。

中一自行分配學位安排

3. 中一自行分配學位的新通知安排由本年度開始實施，所有參加派位中學在完成處理自行分配學位的申請後，須於指定日期通知正取學生家長其子女已獲納入其自行分配學位正取學生名單。鑑於延遲復課對學校的甄選工作帶來影響，因此參加派位中學通知正取學生家長的日期會由原訂的三月三十一日(星期二)順延至四月七日(星期二)。

4. 如有關家長亦有為子女申請不參加派位的直資計劃中學(非參加派位直資中學)學位並已獲通知錄取，家長決定是否保留該學位的限期亦會作出相應調整。若有關家長決定放棄非參加派位直資中學的學位，通知有關非參加派位直資中學及取回《家長承諾書》和《小六學

生資料表》的正本的限期由原訂的四月七日(星期二)順延至四月十六日(星期四)，以保留自行分配學位階段成功申請的學位。請學校通知學生家長上述的修訂安排。

5. 因應上述的修訂安排，本局亦會調整其他相關事項的進度，包括核對小六下學期期考成績的日期。本局會稍後於中學學位分配委員會討論，並向學校發放更新的《中學學位分配二〇一九／二〇學年重要事項進度表》。

Secondary School Places Allocation (SSPA) 2018/2020
Revised Administrative Arrangements on Submission of Scores for Primary 6 (P6)
Second Term Internal Assessment (IA) and
Secondary 1 (S1) Discretionary Places (DP) Applications

In view of the development of the novel coronavirus infection, the Education Bureau (EDB) announced on 31 January 2020 that all schools in Hong Kong would not resume classes on or before 1 March 2020. Affected by the deferral of class resumption, the administrative arrangements in connection with SSPA will be adjusted accordingly to provide schools with sufficient time to handle the related work.

Arrangements on P6 Second Term IA

2. To allow sufficient time for schools to arrange the P6 second term IA and related work, the deadline for submission of the scores of this IA is **extended from 24 April 2020 (Friday) to 11 May 2020 (Monday)**. While the date of class resumption is still subject to the development of the infection, EDB has decided that if classes cannot be resumed **on or before 9 March 2020 (Monday)**, schools will not need to conduct the P6 second term IA or submit the scores. The allocation band of individual P6 students will then be determined by their scaled IA scores obtained at the end of Primary 5 and the mid-year of Primary 6.

Arrangements on DP Applications

3. With the implementation of the New Notification Arrangements for S1 DP applications starting from this SSPA cycle, all participating secondary schools are required to, after processing DP applications, notify parents of successful applicants of their children's inclusion in the Successful Lists for Discretionary Places on a date specified by EDB. In view of the impact of deferral of class resumption on the selection procedures, the date for participating secondary schools to notify parents of successful applicants is **extended from 31 March 2020 (Tuesday) to 7 April 2020 (Tuesday)**.

4. If the parents concerned have also successfully applied for a school place in a non-participating Direct Subsidy Scheme secondary school (NDSS secondary school) for their children, the deadline for these parents to decide whether to retain the offer will also be extended. If the parents concerned decide to decline the offer from the NDSS secondary school and retain the DP place which they have successfully obtained, the deadline for them to notify the NDSS secondary school concerned and retrieve the signed undertaking and the original copy of the Primary 6 Student Record Form is **extended from 7 April 2020 (Tuesday) to 16 April 2020 (Thursday)**. Schools are requested to inform parents of students concerned of the aforementioned revised arrangements.

5. In light of the above revised arrangements, EDB will also adjust the schedule of other related work, including the date for the checking of scores for P6 second term IA. EDB will discuss the related arrangements with the Secondary School Places Allocation Committee, and release the revised Schedule of Major Events for the 2019/20 School Year for SSPA later.
